Teams will consist of seven members, and the times of the fastest four men and one woman will be used to determine a teams' total score. The lowest team score will be declared the winner. A team must have four men and at least one woman finish both runs to be scored.

When completing the entry form, you will need to determine if your team will compete in either the Gold or Silver divisions. The Gold division is open to the most competitive adult racers in the region, including professionals. The hotly-contested Silver division is open to any team not wanting to compete directly with the pros, as professionals are not allowed to race in this division. Any team found to have a pro that has signed up for the Silver division will be disqualified. The race director reserves the right to final division placement of any team. Finally, all participants in the Miller Lite Ski League Championships must be at least 21 years of age, and picture ID's will be required for confirmation. Final registration will take place in the Olympic Room from 5:30pm to 11:00pm on Friday, March 14th. All racers will receive their race bib, t-shirt, sign a release form and will have their ID's verified.

It is mandatory that all teams register by 11:00pm
Friday, March 14th. There is simply not enough time for the computer geeks
to get the race software programming done if there are people filtering in
on Saturday morning. Compliance is appreciated. Team seeding will be
determined by random drawing after registration is complete Friday night.
